# 23-24 Disbursement Dates

Below are the dates that financial aid will disburse/release from the state and federal governments respectively to be sent to the college.

## Important to Notes:

- If you have C-term classes, or "stacked" classes (classes with different start dates spread throughout the term) then your disbursements will be split-up according to your respective enrollment schedule and will not necessarily coincide with the dates listed below.
- Disbursement dates are not refund dates. If refunds are due from a disbursement after charges are fully deducted, then you will need to be sure to allow up to 14 business days from the disbursement date for the funds to load in and any refund due from that portion to be processed out.

## Fall 2023: (August 14, 2023 to December 6, 2023)

- August 31, 2023-HOPE Grant, Zell Miller Grant, HOPE Scholarship, HOPE Career Grant, and Student Access Loan for Technical colleges (SALT).
- August 31, 2023- Federal Pell Grant and Federal Supplemental Educational Opportunity Grant (FSEOG) for A & B term classes.
- September 7, 2023 First disbursement for Federal Subsidized and Unsubsidized Loans. (If you are a first-time borrower, then your first disbursement will be September 14<sup>th</sup>).
- September 28, 2023 Second disbursement for Federal Subsidized and Unsubsidized Loans.
- October 26, 2023 Third disbursement for Federal Subsidized and Unsubsidized Loans.

### Spring 2024: (January 8, 2024 to May 3, 2024)

- January 25, 2024 HOPE Grant, Zell Miller Grant, HOPE Scholarship, HOPE Career Grant, and Student Access Loan for Technical Colleges (SALT).
- January 25, 2024 Federal Pell Grant and Federal Supplemental Educational Opportunity Grant (FSEOG) for A & B-term classes.
- February 1, 2024 First disbursement for Federal Subsidized and Unsubsidized Loans. (If you are a first-time borrower, then your first disbursement will be February 8<sup>th</sup>).
- February 22, 2024 Second disbursement for Federal Subsidized and Unsubsidized Loans.
- March 14, 2024 Third disbursement for Federal Subsidized and Unsubsidized Loans.

### Summer 2024: (May 13, 2024 to July 26, 2024)

- May 30, 2024 HOPE Grant, Zell Miller Grant, HOPE Scholarship, HOPE Career Grant, and Student Access Loan for Technical Colleges (SALT).
- May 30, 2024 Federal Pell Grant and Federal Supplemental Educational Opportunity Grant (FSEOG) for A & B-term classes.
- June 6, 2024 First disbursement for Federal Subsidized and Unsubsidized Loans.
- June 20, 2024 Second disbursement for Federal Subsidized and Unsubsidized Loans.
